## **Intensive In-Home Qualified Community Interventionist (QP) Job Description**

**Position Type:** Contract, Part-Time

**North Carolina Health Partners** (NCHP) is currently looking to hire a **Qualified Community Intervention Specialist** (QP) to work with youth between the ages of 10 and 18 through the Intensive In-Home (IIH) team. This candidate should have at least 2 years of experience serving children and adolescents with mental health and/or behavioral health diagnosis.

**Summary of Position Responsibilities:**

Under the supervision of the Team Lead, the Qualified Community Intervention Specialist (QP) establishes meaningful goals for the consumers. In addition, the QP provides sessions to consumers and families based on identified needs. The QP is responsible for maintaining a treatment team caseload between 6-12 as well as assisting in the completion of PCPs of for consumers being re-evaluated for services.

**Essential Duties:**

- Coordinating and overseeing the initial and ongoing treatment activities;
- Convening the Child and Family Team (CFT) for Person-Centered Planning (PCP);
- Engaging community and natural supports to include their input in the person-centered planning process and updates;
- Completing the PCP updates monthly and ensuring its implementation.
- Consulting with identified medical providers, (for example, primary care and psychiatric) and non-medical providers (for example, DSS, school, DJJDP).
- Ensuring linkage to the most clinically appropriate and effective services including arranging for psychological and psychiatric evaluations;
- Assisting the team leader in monitoring and evaluating the effectiveness of interventions, as evidenced by symptom reduction and progress toward goals identified in the PCP
- Assisting with crisis interventions; and
- Completing 3-month, 6-month, and discharge NC-TOPSS
